
Executive Summary

Group A Offense reporting declined by 1.5% during 2023 when compared to the prior calendar year. Group A Offenses during 2023 also declined by 5.2% when measured against the prior ten-year average. Both the Crimes against Property (-1.6%) and the Crimes against Society (-8.6%) offense classifications experienced a decline in victim reporting last year when compared to 2022. It was only the third offense classification, Crimes against Persons, which experienced a minor increase (0.7%) in offenses with victims reporting an additional three offenses in that classification for 2023. All three offense classifications also remained within expected statistical confines in accordance with past historical victim reporting trends over the previous ten years.

There were several notable offense trends for last year. Several vehicle-related crimes such as vehicle theft and thefts from vehicles saw increased activity last year, especially in historical city hotspots; while other vehicle-related crimes such as the theft of vehicle parts category that includes items such as catalytic converters experienced a significant decline. The majority of Crimes against Persons during 2023 mirrored last year's victim reporting, including sexual assault offenses which saw a consecutive fifth year decline in victim reporting. Fraud also continued to be problematic during 2023 and, while growth in these offenses was primarily static in 2023, the amount of money lost to swindlers increased from 2022 figures. Based on historical crime data, the number of crimes for 2024 is anticipated to range between 1,682 to 1,988 Group A Offenses (68% accuracy / 1 Std. Dev.).

In 2023, the total volume of Calls for Service increased by 60%. Abandoned 9-1-1 Calls (33%), ATV Complaints (89%), Illegal Dumping (89%), MV Stops (126%), Parking Violations (60%) and Traffic Enforcement (38%) have all contributed to this significant increase. Calls for Service projections for the upcoming 2024 year is anticipated to be between 54,764 and 86,260 (95% accuracy / 2 Std. Dev.). Lastly, police department personnel arrested and / or summonsed 2,012 individuals during 2023.

A Word on Reporting Crime to the FBI.....

NIBRS Offense Reporting

The FBI Uniform Crime Reporting Program (UCR) is a nationwide, cooperative statistical effort of more than 18,000 federal, state, county, university and tribal law enforcement agencies across the United States that voluntarily report data on offenses reported or known to them. Since 1930, the FBI has administered the UCR program and has continued to assess and monitor the nature and type of crime throughout the nation. The program's primary objective is to generate reliable information for use in law enforcement administration, operation and management.

The UCR Program was initially designed as a summary system to collect only the most serious offense within an incident. However, the UCR Program began using an "incident-based" reporting process in 1989 to capture every offense that occurs within an incident – up to ten crime offenses per incident may be reported. Now through the National Incident Based Reporting System (NIBRS), law enforcement agencies can report data on a large set of offenses within their jurisdictions that are broken down into two separate offense categories: Group A Offenses and Group B Offenses.

Group A Offenses are then divided up into twenty-eight separate categories comprised of seventy-one different crimes. These Group A Offenses are considered more serious offenses and are divided up into three different Offense Classifications: Crimes against the Person (such as Murder and Sexual Assault); Crimes against Property (such as Fraud and Burglary); and Crimes against Society (such as Narcotics and Animal Cruelty). The table listed below provides the reader with an Offense breakdown by Group and Classification.

Group B Offenses are fewer in number and tend to be minor in nature, such as Disorderly Conduct, Liquor Law Violations and Trespassing. Group B Offenses encompass all the crimes for which the FBI UCR program collects data that are not considered Group A Offenses.


Crimes against Persons

The Crimes against Persons classification increased by three additional offenses in 2023 when compared to the prior calendar year. This equated to a 0.7% increase for the entire offense classification. A comparison of this offense classification during 2023 to the prior ten-year average reveals that the classification experienced a 5.3% decline. However, the classification still remains within statistical boundaries of past victim reporting from the prior ten years.


Victim reporting for just the three aggregated assault categories (Simple / Aggravated / Simple) in this classification declined by one offense. The number of domestic-related assaults reported to police accounted for approximately 49% of all reported crime in this offense classification. More than fifty percent of victims in those domestic-related incidents reported an intimate relationship with the offender.

This classification's Crime Rate was 9.3 Crimes per 1,000 residents.

Crimes against Property



The Crimes against Property classification declined for a third consecutive year in 2023. The offense classification declined by 1.6% last year and a comparison against the prior ten-year average reveals a 5% drop against that historical timeframe. Multiple offense categories, such as Counterfeiting, Destruction of Property and Theft of MV Parts experienced small-to-moderate decreases in victim reporting for last year.

However, several offense categories also saw significant gains during 2023 despite the decrease across the entire offense classification. An uptick in victim reporting was observed in online Extortion, Identity Theft and MV Theft incidents that may be cause of continued concern during 2024 and beyond. Incidents of fraud also continue to remain elevated and might be considered a significant threat to city residents and businesses as offenders bilked victims out of more than \$1.8 million last year. Fraud also accounted for one-third of all reported property crime during 2023.

This classification's Crime Rate for 2023 was 26.2 Crimes per 1,000 residents.


Crimes against Society

The Crimes against Society classification experienced ten fewer offenses in 2023, which resulted in an 8.6% decline for the year. There were minor declines in most of the offense categories in this classification with the exception of drug-related offenses. The offense classification in its entirety also saw an 8% decline when compared to the prior ten-year average.

Drug-related offenses in 2023 were identical to last year's reporting figures. Drug offenses have been elevated for the last two years with a significant increase reported previously in 2022. However, as stated previously, reported drug offenses have been in a downward trend in the city for more than a decade.

This classification's Crime Rate for 2023 was 2.2 Crimes per 1,000 residents.

Robbery


The Robbery offense category increased from ten offenses during 2022 to nineteen offenses in 2023, a 90% increase between the two back-to-back years. It is the first increase in the offense category since 2020, when the robbery category reported a tenyear high of twenty-two robbery offenses for that year. Last year's robbery count continues to be in statistical alignment with the prior ten-year reporting average.


Eight of those nineteen robbery incidents during 2023 were unarmed robbery events. Suspects were charged in half of those eight unarmed robbery events as victims knew who the offenders were in those incidents.


Robbery of commercial establishments made up 42% of the total number of robbery events in 2023 (8 robberies), which is an increase from the three commercial robberies documented the prior year. Seven out of these eight commercial robberies occurred at a South Attleboro business. Four of these eight commercial robberies also involved a firearm


There were two areas in the city where robbery events clustered in 2023. The first area was in the general uptown area with six robbery events (32%) reported within a quarter-mile or less of Fiske Square. The second area of concentration was along Washington Street on Patrol Beat 7 with five robbery events reported between Mendon Road and the Rhode Island state line.


Ten suspects were charged in connection with eight robbery events last year. Six out of those eight suspects were male parties with an age range that spanned between 15 and 60 years-old for identified subjects.

2024 Outlook

The rate of robbery increased to four per 10,000 residents in 2023, compared to the two per 10,000 residents reported the prior year. Even with the increase in robbery events in 2023, the number of documented events were within statistically determined bounds as predicted.

As discussed in previous years, the general uptown area around Fiske Square and the Common remain vulnerable to opportunistic robbery events, as do those commercial establishments in South Attleboro which are easily accessed by the interstate and/or in close proximity to the state line. Robbery events may continue to trend upward in 2024, but should remain within statistical boundaries based upon the prior tenyear average.


Assault


Overall assault events (Simple / Aggravated / Sexual) declined during 2023 by 0.3%. While the Simple Assault offense category did experience a 5.5% increase during 2023, the Aggravated Assault and Sexual Assault offense categories declined by 9.2% and 26% respectively. Both the Simple Assault and Sexual Assault categories also showed a decline against their prior ten-year average. Note that this is the fifth consecutive year that a decline has been observed in victim reporting of Sexual Assault incidents.


Domestic-related assaults accounted for approximately 49% of the offenses in the Crimes against Person classification in the city during 2023. Approximately fifty percent of these assaults reported during 2023 occurred with an intimate partner, compared to the fifty-one percent of assaults as reported during 2022 and the forty-four percent reported during 2021. Assaults involving family (17%) and acquaintances (18%) were the next largest relationship categories between victim and offender. Assaults committed by strangers in 2023 accounted for 8% of incidents.


Female individuals accounted for 49% of all victims, which is up from the previously reported 48% during 2022. Two age categories (25 - 34 / 35 - 44) were the most affected age groups for both victims and offenders. Both age groups accounted for 40% of the total. The Under 18 age category was the third most-affected age group with more than 16% of all affected subjects.


Alcohol was found to be a factor in more than 23% of assault incidents, which is an increase from the 21% documented during 2022. It counted as a factor in more than one-in-three domestic assaults as well as in 25% of all assaults involving family members. Assaults also primarily occurred within the home in 2023 (65%), while Sturdy Hospital, Arbour Fuller and the High School were found to be the largest city hotspots for assault reports last year and accounting for 11% of documented assaults.












2024 Outlook

All three assault categories are expected to maintain their current trajectories into 2024 based upon prior ten-year reporting averages which revealed small declines in several categories last year without much statistical significance.

Fifteen offenders were found responsible for 10% of documented assaults in 2023. This is a significant drop from the 24 offenders responsible for the 18% of assaults in 2022.

Assaults still continue to cluster in the more densely populated uptown area and any proposed intervention(s) should work to focus upon the most affected demographic.




Burglary


Burglary offenses experienced a second consecutive, yearly uptick during 2023 with a twenty-two percent increase (12 additional offenses) in such crimes when compared to 2022. The increase in burglary offenses during 2022 was 17%. The number of burglaries in 2023 were still below the prior ten-year average of 110 burglary offenses, which is a 40% decline against that prior ten-year timeframe. Burglary offenses have been in a downward trend since 2011, when the department documented more than 250 reports of burglaries.


Forty-nine percent of affected buildings in 2023 were residential units, compared to the sixty percent of buildings in 2022. Suspects in almost two-thirds of those affected residences made entry through a door of which one-in-four doors were left unlocked / unsecured. Over 60% of affected residents reported no missing items from their homes last year. More than half of those residential burglaries were also believed to have occurred during daytime working hours between 8AM and 5PM. Suspects were most active between August and October of 2023 when approximately half of all residential burglaries were reported.


An additional thirty percent of affected buildings housed city businesses. Seventy percent of those burglaries affecting city businesses occurred between 11PM and 4AM. While the number of affected city businesses remained the same as 2022 (20 businesses), the amount of declared loss in 2023 was more substantial at an estimated \$73,776. Estimated losses during 2022 was just \$5,000. The higher losses reported during 2023 were due to the theft of vehicles from at least two business locations.


Charges were brought against suspects in approximately 50% of all burglary cases in 2023.












2024 Outlook

Burglary offenses returned to pre-Covid levels, but remain well-below numbers reported by victims ten or more years prior.

Several factors continue to suppress burglary events including cheaper home monitoring systems and remote work options. Route One businesses will continue to be at-risk after closing, especially due to criminally affiliated groups operating throughout the region / state. While commercial burglaries may rise in 2024, residential burglary events are expected to remain flush with the tenyear reporting average.






The Theft from Motor Vehicle category experienced its first increase since 2020. It was a forty-nine percent increase when compared to 2022. This offense category had experienced significantly steep declines during 2021 and 2022. The number of reported thefts during 2022 was even the lowest number of such thefts reported in the city in more than a decade. Even with the large increase in such thefts reported last year, the category continues to be aligned with the prior ten-year reporting average.


Theft from vehicles trended upwards throughout the 2023 reporting year, peaking in July before dropping off dramatically until November. Forty percent of such thefts were reported between May and July. Theft patterns in 2023 were also similar to theft patterns from last year. More than seventy-five percent of vehicles were broken into between 7PM and 7AM. Narrowing that timeframe down further, forty-five percent of victims last year reported their vehicle being affected between 12AM and 5AM.


Offenders still appeared to be more active during the work-week as opposed to the weekends, with three weekday late-evenings / early-mornings (M – W – Thu) accounting for approximately sixty percent of all theft events. Purses / Wallets were reported missing in almost one-third of incidents in 2023, an increase from the 27% reported during 2022. Seventy-five percent of victims also reported their vehicles being unlocked at the time compared to the roughly 85% reported in recent years.


More than forty-five percent of overall reported theft from vehicles was documented in the general uptown area. In regards to this generalized hotspot, twenty-five percent of total breaks were reported within half-mile of Fiske Square.

2024 Outlook

Both the patrol and detective divisions identified twenty-one suspects involved in seventeen separate theft incidents in 2023. The crime is not generally lucrative; but it is a crime of opportunistic nature for certain individuals.

The identification of habitual offenders and the slight decline in unlocked vehicles has assisted in containing larger crime sprees. Proactive patrol, particularly between the prime offending hours of 11PM to 5AM, is highly encouraged in areas where opportunity has historically existed.

Expect this crime category to increase during 2024.


MV Theft


The offense category of Motor Vehicle Theft documented an additional ten vehicle thefts during 2023 when compared to the prior year. This is a 37% increase in theft activity when compared to 2022. A forty-six percent decline in such thefts was noted during 2022. While vehicle thefts in the city have trended downwards over recent decades due to technological advances, there still remains some theft-related technological issues that have permitted more tech-savvy offenders to steal vehicles as they adapt to the changing times.


Several Motor Vehicle Theft hotspots closely mirror the same hotspots as the theft from motor vehicle category. Twenty-five percent of vehicle thefts occurred in the general uptown area not far from Fiske Square. An additional twenty-five percent of vehicle thefts occurred on Patrol Beat 7, which neighbors the state line of Rhode Island. A large number of vehicle thefts were also reported occurring on Patrol Beat 7 over the last two years (2021 – 2022).

Sixty percent of stolen vehicles were less than ten years old, which is the same percentage reported for 2022. The "hottest" vehicles last year were Hyundai / KIA models, accounting for more than 20% of all thefts. Nissan and Ford vehicles tied for the second top spot. Vehicles left running and / or with the keys left in an unlocked vehicle contributed to 30% of thefts last year. In more recent years, the percentage of key / running vehicle access was as high as eighty-one percent.


Sixty-seven percent of stolen vehicles were recovered, which is just slightly down from the 70% recovered during 2022. Five vehicles were recovered locally in Attleboro, while an additional thirteen vehicles were recovered out-of-state in Rhode Island. In addition, officers were able to identify and / or charge ten individuals in connection with nine of these thefts.












2024 Outlook

While this particular theft category is expected to continue its downward trend, the offense category is not without its concerns. Hyundai and KIA vehicles, which were the "chosen" brands for car thieves last year, will continue to remain problematic due to design and manufacturing issues which permit certain vehicle years prone to theft activity. Several Rhode Island-based groups continue to actively target these vehicles for both transport and the commission of criminal offenses.

The offense category was unchanged for 2023 against the ten-year average; however, the category may see an uptick in theft during 2024.




Shoplifting


Retail businesses reported an increase in shoplifting events during 2023. Documented offenses increased by 30% for last year, which is a significant change from the zero percent change reported for calendar year 2022. Even with the large increase in theft events, the offense category continues to be within expected, statistical range of the prior ten-year reporting period. The offense category experienced a 21% decline when compared to that past, ten-year reporting period.


The number of documented thefts over the last decade were highest between 2013 and 2016, when city businesses were reporting over 200 plus theft events almost each year. Closures of some retail business chains, along with recent policy changes involving theft-related events, have curbed some reporting of shoplifting activity.


This past calendar year is the third, consecutive year that twenty-four city businesses reported a shoplifting event. Store personnel reported approximately \$24,500 in stolen merchandise during 2023, a decrease from the \$33,000 in total loss reported during 2022. Total loss equated to an average of \$216 per theft event, which is a decline from the average loss of \$387 per theft event documented during 2022. The losses from just four stores alone accounted for 34% of the total lost citywide.


Foodstuffs and liquor once again topped the list of most-stolen items for 2023, accounting for more than 60% of stolen items last year, but only \$5,372 in losses. Health and Beauty products accounted for nineteen percent of known dollar loss (\$9,800) last year followed up by the theft of clothing (\$5,374). Members of the police department affected twenty-three arrests and summonsed an additional sixty-four individuals during 2023 that led to a 59% clearance rate for such theft events.














2024 Outlook


These type of theft events have been in a state of decline since 2014. Seventy-six percent of these events occur in South Attleboro, which is a small decline from the 81% reported there during 2022.


The number of actual thefts is believed to be higher than what is reported to the police department due to third party reporting practices and store policies.


Due to these factors, this type of theft is expected to stay in a state of decline this coming year unless businesses make policy changes that reflect the nature of the problem that theft represents to their bottom lines.


Fraud


Fraud offenses are comprised of seven separate sub-categories for the purposes of this report. Victim reporting of various fraud offenses closely mirrored victim reporting from 2021 and 2022, though reporting does remain highly elevated when compared to pre-Covid reporting trends. There were nine fewer fraud offenses reported in 2023, which resulted in a 2% drop in fraud for last year. Fraud will continue to be the "crime of choice"; fraud also accounted for one-third of all property crime reported in the city during 2023. Eighty-five percent of affected victims were city residents; this percentage was 78% during 2022. Only thirty-five percent of victims were adults aged fifty-five or older – this is a significant difference from the fifty-three percent of such victims reported in 2022. While fewer older residents were victimized, they still shouldered the heaviest losses and accounted for 73% of total loss across residents of all ages. It should be noted that total loss for businesses and residents amounted to \$1,858,890. Last year's total losses were an increase from the \$1,652,231 loss reported during 2022.





2024 Outlook


Federal Trade Commission data shows that residents reported losing nearly \$10 billion to fraud in 2023, more than a billion dollar increase over the previous year. In Attleboro, individuals 65+ lost the most with an average loss of almost \$15,813 per victim, compared to the 55 to 64 category who reported an average loss of \$7,631. Reports of mail theft have declined, while unemployment fraud and imposter scams (such as grandparent scams) remain stubbornly high. Expect Fraud to either remain stable or to continue climbing in 2024 and well beyond.


Drug Offenses


Drug-related offenses during 2023 were consistent with prior 2022 calendar year reporting. There was no change in the number of reported offenses between 2022 and 2023. The number of drug offenses do remain elevated when compared to 2020 and 2021. However, drugs offenses have been in a general state of decline for more than a decade. While the offense category showed neither an increase nor decrease when compared to the prior year, the category has experienced a 15% decline when compared against the ten-year average.


Department personnel arrested and / or summonsed sixty-eight individuals during 2023 in connection with fifty-six drug-related offenses in the city. The number of arrested / summonsed individuals last year is an increase from the fifty-four such individuals documented in 2022. Fifty-four percent of reported incidents in 2023 were due to a dispatched call for service made by a business or citizen, which is a minor decrease from the fifty-five percent of incidents reported in 2022. Seventy-nine percent of offenders were male with an average age of 29, while the remaining twenty-one percent of female offenders had an average age of 32.


The possession or sale of suspected cocaine / crack-cocaine accounted for thirty percent of incidents last year, which is a decrease from the thirty-six percent reported in 2022. Suspected heroin / fentanyl accounted for another twenty-eight percent of offenses. As noted in previous annual bulletins, the total number of drug crimes reported on a yearly basis should be considered skewed as they <u>do not</u> include drug-related overdose incidents reported to the department. For example, including a drug possession for an overdose-related event would add an additional 109 drug offenses towards the FBI's societal crimes category for the city of Attleboro for 2023 alone.












2024 Outlook

Drug offenses during 2023 remained relatively flat, while overdose events during that same year declined by 8%. Both overdose locations and drug offense locations in 2023 continued to "overlap" with some known crime and disorder hotspots both uptown and in South Attleboro.

While overdose events are expected to continue their decline, drug use is expected to persist and possibly increase during 2024. Targeted enforcement uptown, along with several smaller areas of South Attleboro, may contribute to increased reporting and a higher number of arrests.
